

Domestic market operations total 4.8 bln reais in October

Domestic market funding operations via securities totaled 4.8 bln reais in October, led by debentures, which accounted for 67.2% of the total volume raised, equivalent to 3.2 bln reais. There were several major operations, such as the AES Sul Distribuidora Gaúcha de Energia offering, which raised 1.1 bln reais, the CPFL Energia issue, worth 620 mln reais, both of which distributed through ICVM 476, and the Terminal de Contêineres de Paranaguá – TCP offering, distributed with ample placement effort through ICVM 400, which raised 607.5 mln reais.

Also in the fixed income segment, mortgage-backed securities and credit receivables offerings totaled 758 mln and 46 mln reais, respectively, in October, a month in which there were no commercial paper issues. In the equity segment, Centro de Imagem Diagnósticos raised 766.4 mln

reais, the year’s ninth share issue, increasing the year-to-date equity market total to 8.8 bln reais, 52% down on the first ten months of last year. In the same period, Brazilian corporate fixed income issues totaled 56.6 bln reais, down by 19.2%.

International offerings followed the same accelerated pace that began in May of this year. There were two more international issues in October, from Votorantim Cimentos, totaling 500 mln dollars, and Ultrapar, totaling 750 mln reais, both through 10.1-year bonds.

Highlight of the Month

At the close of October, three new share issues were being analyzed by the CVM and ANBIMA, through the agreement entered into with the Commission. These included the IPO of Log Commercial Properties e Participações and the follow-on offerings of Sanepar – Companhia de Saneamento do Paraná and Construtora Tenda. Public debenture issues under analysis, to be distributed with ample placement efforts, total 927 mln reais, led by Comgás’s offering of 500 mln reais. In regard to those domestic issues in the first ten months, debentures and equities (primary issues and secondary distributions) were the most used assets, accounting for 60.8% and 13.4% of the total, respectively. The CVM is also analyzing mortgage-backed securities and credit receivables offerings totaling 4.3 bln reais and 1.8 bln reais, respectively.




Total Fixed Income and Equity Offerings (BRL mln)



Total Fixed Income Offerings




Total Debenture Offerings






Sector - Equities Jan to Oct/2016




Allocation of Proceeds from Primary Equity Offerings

Allocation of Proceeds







May/16 to Oct/16 (BRL mln)




